STATE THAT:

- 1) to be aware that the School is a parish school within the meaning of Law 62/2000 and as such performs its public service in compliance with state and regional regulations on childhood education
- 2) to share the educational project inspired by the Christian values of life; to be aware that the IRC is an integral part of the educational project of this Catholic parish school and represents an inalienable cultural aspect for the formation of the person in respect of pupils of different cultures, and to choose that their child avails itself of the Teaching of the Catholic Religion carried out according to the modalities provided for by the regulations and in full respect of the freedom of conscience of each family;
- 3) to accept the school regulations, in particular the rules concerning school organisation and payment of fees;
- 4) to take note that the School's educational action, aimed at facilitating the fulfilment of the family's educational tasks, is carried out in close collaboration with the family itself which is asked to actively participate in the life of the School
- 5) to take note that the annual enrolment fee is € 100 and to be aware that in case of withdrawal of enrolment the fee will not be refunded;

to take note that the monthly tuition fee to be paid by the family for the year 2025/26 will be calculated as follows:

PRE-SCHOOL

FOR RESIDENTS

The annual fee to be paid by families for the 2025/26 school year is:

- € 1,850.00 for those who have chosen the traditional section
- € 2,350.00 for those who have requested the bilingual section;

FOR NON-RESIDENTS

For non-residents newly enrolled in the traditional section and in the bilingual section the annual fee will be the same as for residents only in the event that a convention is stipulated between the school and the municipality of residence (it will be the responsibility of the family to present the pre-filled application form provided by the school to the municipality of residence).

If it is not possible to enter into an agreement with the municipality of residence, the annual fee to be paid by the families for the school year 2025/26 is

- € 2,050.00 for those who have chosen the traditional section;
- € 2,550.00 for those who have requested the bilingual section.

For non-residents already attending the 2024/25 school year, the procedure is the same as for new enrolments; in the event of failure to sign an agreement with the municipality of residence, the annual fee to be paid by families for the 2025/26 school year only is

- € 1,950.00 for those who have chosen the traditional section
- € 2,450.00 for those who have requested the bilingual section;

PRIMAVERA (SPRING) SECTION

The annual fee to be paid by families for the 2025/26 school year is €2,900.00 without distinction for resident and non-resident families.

The Management Committee reserves the right to adjust the amount of the annual fee, payable monthly, before each school year, according to budgetary sustainability.

INFORMATIVA D. Lgs.vo "PRIVACY CODE" Regolamento Europeo 2016/679 27/04/2016

As defined by the law, article 13, by the European Regulation 2016/679 regarding the protection of personal information, the school will treat personal information of the students and of their parents and guardians, such as the ones concerning physical and mental health and religious affiliation, exclusively for the management of the requested service, as well as to the training and educational purposes and administrative obligations, and will also be carried out with the use of IT tools, within the limits necessary to pursue the above mentioned purposes. The confidentiality and security of the collected data will be guaranteed.

The personal information may be communicated, according to the regulations in force and for what is within the competence, to the School Authorities and other recipients by law and regulation, to local health care facilities, to public or private organizations that collaborate with the school, to the transportation companies and those who provide food catering, to insurance companies with which the insurance policies were stipulated and, upon specific request, to any other schools in which the pupils were to be transferred. The personal data of the students can be communicated to the administration offices of the museums, exhibitions and other subjects that request them during tours and school field trips.

The data may be brought to the attention of individuals in charge of internal or external processing, whether they are employees, collaborators, or external entities. The provision of personal information is mandatory for the right performance of services and failure to provide it, would make it impossible to perform them. The personal information will not be disclosed to third parties, other countries or international organizations outside the European community. The data will be stored for a period of time not exceeding the time necessary for the pursuit of the purposes for which they are collected and processed and, in any case, in compliance with the terms of conservation required by current regulations.

The rights provided for by the abovementioned regulation are recognized to the interested parties, specifically the following:

- . the right to access their personal information, to request correction, updating and rectifying, if incomplete, erroneous or collected in violation of the Law, as well as to oppose their processing for legitimate reasons.
- . the right to withdraw the consent at any time without prejudice to the lawfulness of the processing carried out before the revocation.
- . the right to data portability
- . the right to file a complaint with the supervisory authority.
